

Bachelor of Education Post Secondary Credit Requirement

This sheet outlines details in satisfying the BC Teacher Regulation Branch (TRB) post-secondary credit requirement in completion of a Bachelor of Education degree. Approved Teacher Regulation Branch Elective Coursework

Additional academic course/credit requirement, as required by the BC Ministry of Education Teacher Regulation Branch (TRB)), can be satisfied as follows:

- A total of 15 additional **ACADEMIC** credits must be completed
- Courses coded from the following list **cannot be used to satisfy this requirement:**
 - CSW, CYC, ECEC, EDUC, ENGC, ENGE, ENGM, ENGR, HOSP, HSLC, HHS, HSER, INTD, MEDI, NURS, LEAD, LING, PPSE, RECR, RELI, RMGT, RMOT, SCSW, SEAC, SSER, TOUR, and TRMT
- **Pursuing an official VIU minor is an option.**
 - Course work to meet VIU minor requirements in academic disciplines will count towards the additional academic course TRB requirement **AND** the additional VIU undergraduate course requirement outlined below.
 - Selecting minors that support a Secondary teachable area is encouraged.
 - Please see a Faculty of Education Advisor for more details and/or support in pursuing a minor.

Undergraduate Elective or Transfer Coursework

Additional course/credit requirement, as required by VIU, can be satisfied as follows:

Direct Entry (Year 1) Students

- A total of 27 credits must be completed
- Any VIU course, including those not permitted in the Additional Academic Course/Credit Requirement listed above
- Practicum/field experience based courses/credits are **not** accepted

Year 3 Entry Students

- A total of 36 credits must be completed
- Any VIU course, including those not permitted in the Additional Academic Course/Credit Requirement listed above
- Practicum/field experience based courses/credits are **not** accepted
